**Tuition for the 2023-2024 School Year**

Kindergarten-Grade 8	\$19,500
Preschool five-day, full day	\$20,400
Preschool three-day, full day	\$16,100
Preschool two-day, full day	\$14,400

**Enrollment Contract Cancellation:** Families who choose not to return to FXW after re-enrolling are asked to notify the School in writing on or before **April 30, 2023**. Cancellation of the contract by this date will excuse any remaining tuition balance, but the enrollment deposit is non-refundable and non-transferrable. If written cancellation is received on or before April 30, 2023, FXW will issue a refund of the first tuition installment paid in April. If notice of cancellation is given after April 30, 2023, no refunds will be given, and the family will be responsible for any outstanding tuition balance.

**2023-2024 Fees**

**Application Fee:** A fee to apply for admission to FXW, which helps to defray the costs of administrative processing regardless of admittance, is \$80 per applicant.

**Curriculum Fee (Formerly Activity Fee):** The curriculum fee covers the costs that support the robust curriculum we offer at FXW. This includes, but is not limited to, student materials, books, supplies for the classrooms, excursions and field trips, religious services and Sacramental preparation, as well as special events and school-wide celebrations.

- Preschool through Grade 3: \$530
- Grades 4 through Grade 7: \$580
- Grade 8: The Grade 8 fee is \$795 and includes all activities listed above as well as Graduation activities

**Tech fee:** The technology fee at FXW helps defray the total costs FXW invests in its Information Technology program. This includes the cost of a student's use of an iPad or Surface device (inclusive of warranty, case, and software) as well as Help Desk support for students and families. The annual technology fee of \$190 for Preschool and \$300 for Kindergarten through Grade 8 will be billed per child in September.

**Matriculation Fee:** There is a one-time cost for matriculation of new families of \$410.

**Co-Curricular and After-School options are separate pay-per-use expenses.** Fees for these activities will be announced and charged at the time of the child's enrollment in the activity.

**Extended Day and Inter-Campus Bus:** Extended Day and the inter-campus bus will be determined closer to the beginning of the 2023-2024 school year.

### **Finance Fees**

Finance fees vary depending on your payment method. There is a \$2 per transaction processing fee for the e-check (ACH) option. For each credit card transaction, there is a \$.30 processing fee plus a percentage fee, which varies depending on the credit card used:

Please note that the above fees will simply be added to your monthly invoices. Effective April 1, 2022, there will be a 2% late fee assessed monthly for late payments, and there will also be a \$40 NSF fee for returned checks.

### **Billing and Payment**

FXW requires that all families are enrolled in our AutoPay program. AutoPay is the process which allows FXW to charge your debit/credit card or bank account for the payment due each month. You may choose to register with a credit/debit card or checking account. You are automatically charged for the amount shown on your latest statement on the 15th of each month.

Tuition can be paid in 1 or 9-month installments, with the first payment due on April 15, 2023, and final payment due December 15, 2023. The amount due each month will be automatically charged to your credit/debit card or bank account. At re-enrollment you will be asked to choose the number of installments that you prefer and the form of payment that is most convenient for you.

### **Deposit**

Tuition includes a non-refundable and non-transferable deposit of \$1,000.

### **Tuition Due Dates**

1-Payment Option: Due on April 15, 2023

9-Payment Option: Due on the 15th of each month *April 2023* through *December 2023*
